

# Wild Sheep Legacy Foundation, Inc. Trustee's Code of Conduct

The Wild Sheep Legacy Foundation (WSLF) plays a significant role in the philanthropic community and is committed to being an innovative, unique and responsive organization. The only way to achieve this commitment is by providing a high level of service, demonstrating leadership, and acting with unquestionable integrity.

As a tax-exempt, public charity, WSLF has a fiduciary obligation to its donors and the general public. The issue of public trust demands that Trustees (the "Trustee" or "Trustees") of WSLF's Board of Trustees (the "Board") act with integrity and in accordance with high ethical principles in all its activities. WSLF also expects Trustees to recognize and avoid activities and relationships that involve or might appear to involve conflicts of interest and behavior that might cause embarrassment to WSLF or compromise its integrity. Accordingly, WSLF is committed to integrity as the fundamental guiding principle for all its officers, employees, trustees, contractors, and vendors. WSLF has prepared this Trustee's Code of Conduct (the "Code") to reaffirm this commitment.

The following principles provide the framework that shape WSLF's business practices:

- WSLF and its Trustees will abide by the letter and spirit of all applicable laws and regulations and will act in such a manner that the full disclosure of all facts related to any activity will reflect favorably upon WSLF.
- WSLF and its Trustees will adhere to the highest ethical standards of conduct in all activities.

- WSLF and its Trustees will deal fairly and honestly with those who are affected by their actions and treat them as we would expect them to treat us if the situation were reversed.
- WSLF will promote relationships based on mutual trust and respect and provide an environment in which individuals may question a practice or action without fear of adverse consequences.
- WSLF believes that the exchange of information, except for information of a confidential or proprietary nature, promotes performance, teamwork, and innovation. Directors are encouraged to share their ideas, suggestions, and concerns with the organization.
- In line with the WSLF Mission and values, the Board of Trustees will support and promote the Wild Sheep Foundation conservation and fund-raising activities when appropriate.

#### GENERAL CONDUCT

Trustees are expected to refrain from misconduct in their capacity as a Trustee. Misconduct is grounds for immediate termination from the Board.

#### CONFLICTS OF INTEREST

Trustees owe their loyalty to WSLF and their energies when called upon to conscientiously fulfilling the fiduciary responsibilities of an WSL Trustee. In this regard, it is contrary to WSLF policy for a Trustee or his/her "Family Member" (being defined as a spouse, domestic partner, parent, child, friend or any other person or entity with which the Trustee is closely identified) to:

• Hold or maintain an inappropriate financial or management interest in or relationship with (i) a supplier, donor, depositor or borrower of WSLF, (ii) any enterprise which extends financing accommodations to, or receives accommodations from WSLF, or (iii) any other entity that does business with WSLF, unless such interest is disclosed to and approved by the appropriate WSLF Board Committee. A Trustee shall not be deemed to have an interest in or a relationship with any corporation, firm, association or other entity whose securities are publicly traded solely because such person together with such person's

parents and spouse, own in the aggregate, or have an aggregate beneficial equity interest, less than 5% of such company's shares.

## CREDIT AND CRIMINAL BACKGROUND CHECKS

Due to the fiduciary nature of WSLF's operations, Trustees acknowledge, understand, and consent to WSLF completing a criminal record search, and a credit agency or other background report on each Trustee on an annual basis. A copy of any such report will be provided to the Trustee.

#### **GIFTS**

No personal gifts should be offered or received where the gift is intended to influence a person to improperly exercise business or professional judgment.

## REPORTING AND INVESTIGATION OF VIOLATIONS

As part of its commitment to ethical and legal conduct, WSLF expects its Trustees to bring any information regarding suspected improper conduct whether or not under this Code to the attention of the Board. To the extent possible, the identity of the Trustee making the report will be kept confidential. Trustees will be expected to cooperate in the investigation of any alleged violation of the Code. If the result of WSLF's investigation indicates that corrective action is required, the Board will decide what steps should be taken to rectify the problem and prevent its recurrence.

## DISCIPLINE FOR VIOLATIONS

Disciplinary actions may be taken for:

- Authorization of or participation in actions that violate the Code.
- Failure to report a violation of the Code or to cooperate in an investigation.
- Retaliation against an individual for reporting a violation or possible violation of the Code.

Disciplinary action may, when appropriate, include termination from service on WSLF's Board.

## TRUSTEE ACKNOWLEDGMENT
