**PLEASE NOTE:** Wild Sheep Legacy Foundation (WSLF) and Wild Sheep Foundation (WSF) Investment Policy Statements (IPS) govern both the **WSLF Endowment Fund** and the **WSF Conservation Fund**. The WSLF is a Supporting Organization (Foundation) of the WSF and is governed by a Board of Trustees made up of Life Members of WSF. The **WSLF Endowment Fund** is an endowed fund whereby CPI adjusted corpus is protected and preserved. The WSLF IPS includes a spending policy target of approximately 4% annual distribution to WSF to fund mission programs as directed by the donor. The **WSF Conservation Fund** is a “quasi-endowed” Fund with a similar (i.e., approximately 4%) annual distribution to fund mission programs as directed by the donor. However, while the general intent is to maintain a CPI adjusted corpus, at WSF Board of Directors’ discretion, the **WSF Conservation Fund** corpus can be used for mission critical programs and initiatives. The phrase “Area of Greatest Need” used above is determined by WSF and/or WSLF (as applicable) at its discretion. For copies of WSF and WSLF Fund Agreements, Investment Policy Statements and/or Bylaws please contact the WSF headquarters.
