The Wild Sheep Foundation’s Ram Lay-Away Program™ was developed to provide qualified first-time sheep hunters with an opportunity to book a sheep hunt and hunt via a subsidized deferred deposit plan. WSF will contribute \$15,000 towards the cost of a hunt, which will be paid to the approved outfitter.

Once an applicant is approved and the hunt is chosen, they will make a deposit of one-third of the hunt to WSF. The second third is due 18 months from booking. The final payment is due 60 days prior to hunt start date.

FINE PRINT: This program is intended for first-time sheep hunters. If the hunter has previously hunted aoudad sheep it does not disqualify them from this program. The WSF Ram Lay-Away Selection Committee reserves the right to select applicants at their discretion. Should an approved hunter draw a tag, win a hunt in a raffle or otherwise be offered a first-time hunt prior to their Ram Lay-Away hunt, they will be offered an opportunity for a refund or can opt to stay in the program since they were a first-time hunter when initially approved. Hardship withdrawals will be considered on a case-by-case basis, however, hunt dates cannot be extended or changed from the listed dates on the contract. In the case of a hardship withdrawal, all efforts to move the next hunter into a slot will be exerted, however, WSF, sponsors and outfitters should be informed up front that in the event of a hardship withdrawal WSF has the right to switch out hunters or utilize booked hunt for a raffle auction.
